OFFICE ORDER

The terms and conditions of regularization are as under:-

TERMS AND CONDITIONS

01. That the appointment/regularization is purely on temporary basis and services are liable to be terminated by giving one month's notice.
02. That the regularization shall be subject to medical fitness for which a certificate of fitness from the Chief Medical Officer/Medical Officer concerned shall have to be produced by them immediately before joining.
03. The appointment/regularization shall be subject to the verification of character and antecedents of the candidate being considered for regularization as provided in the HP Financial Rules.

04. That the appointment/regularization will carry the liability to serve in any part of Shimla District.
05. That an oath of allegiance to the constitution of India shall have to be taken.
06. That the service rules as are applicable in H.P. for the post of Clerk or may be made applicable/amended subsequently by the Govt. in future shall regulate the service conditions.
07. Educational qualification certificates, Character Certificate, Himachali Certificate, Schedule Caste/Schedule Tribe Backward Classes certificate, etc. if applicable issued by the competent authority will have to be produced at the time of joining:
08. The Seniority of the candidate will be reckoned from the date of their joining.
09. The appointment will be subject to the verification of his credentials and genuineness of the certificates, degree etc.

If the offer of appointment on the above terms and conditions is acceptable to them, they may submit their letter of acceptance in the concerned office within 15 days from the date of issue of this order failing which the offer shall stand cancelled.
